Medi Assist TPA is a wholly owned subsidiary of the Company and is one of the TPAs appointed for administering the Ayushman Bharat linked health scheme in Jharkhand state.

Medi Assist TPA has fully co-operated with the officials during the proceedings and responded to the clarifications and details sought by them.

There is no impact on the financials of the Company and the business operations of the Company and Medi Assist TPA are also not impacted due to the search and are continuing as usual.
