# V-DAY CELEBRATIONS | President says Russia will win Ukraine war

## North Korean troops join scaled back Putin parade

AP MOSCOW

Russian President Vladimir Putin on Saturday voiced confidence of victory in Ukraine as he oversaw a military parade on Red Square commemorating the defeat of Nazi Germany in WWII, a show that didn't include heavy weapons for the first time in nearly two decades.

Security was tight in Moscow as Putin and foreign leaders attended the parade, which was scaled down even as a US-brokered three-day ceasefire eased concerns about possible Ukrainian attempts to disrupt the festivities. Putin, in power for over a quarter-century, has used Victory Day, Russia's most important secular holiday, to showcase the country's military might and rally support for his military action in Ukraine, now in its fifth year.

Putin hailed Russian troops fighting in Ukraine, declaring they "face an aggressive force



that is armed and supported by the Nato, and are fighting for a "just cause".

"Victory has always been and will be ours," Putin said, as columns of troops lined up on Red Square. "The key to success is our moral strength, courage and valour, our unity and ability to endure anything and overcome any challenge."

But in a notable shift this year, the parade took place without tanks, missiles and other heavy equipment, aside from a traditional flyover of

combat jets.

Officials explained the sudden change of format by the "current operational situation" and said additional security measures have been taken in response to the threat of Ukrainian attacks.

State television commentators said the heavy weaponry was more needed on the battlefield in Ukraine.

For the first time, Saturday's parade featured troops from North Korea (R), tribute to Pyongyang that



sent its soldiers to fight alongside Moscow forces to repel a Ukrainian incursion into Russia's Kursk.

### TRUMP TRUCE

US President Donald Trump announced Russia and Ukraine have bowed to his request for a ceasefire running Saturday through Monday and an exchange of prisoners, declaring the break in fighting could be the "beginning of the end" of the war. Russia declared a unilateral ceasefire for Friday and Saturday, while President Volodymyr Zelenskyy announced a truce that was supposed to begin on May 6, but neither of them held as the parties traded blame for continuing attacks.

# BAHRAIN DETAINS 41

## IRGC LINKS

Dubai: The Bahrain Ministry of Interior said on Saturday it had arrested 41 people it alleges are part of a group affiliated with Iran's Revolutionary Guard. It said investigations are on to take action against anyone affiliated with the group but did not provide further details.

A US strike overnight killed at least one sailor and injured 10 others aboard a cargo vessel that caught fire, a news agency affiliated with Iran's judiciary reported. It was unclear if the ship was one of the two tankers the US acknowledged striking.

Iranian foreign ministry spokesperson Esmail Baghaei said the country was not paying attention to "deadlines" and Tehran continues reviewing a US proposal related to ongoing negotiations, according to state-run IRNA.

Mazaher Hosseini, affiliated with the office of Iran's former supreme leader, told a gathering Supreme Leader Mojtaba Khamenei was in "complete health" and he would eventually appear in public. CNN reported Mojtaba was out of public view but still



**HMS DRAGON HEADS TO WEST ASIA FOR 'STRAIT MISSION':** The Royal Navy is sending a warship to West Asia where it could join an international mission to safeguard shipping in the strait. HMS Dragon, a type 45 destroyer, will "pre-position" in the region ahead of its "potential role" in what the Ministry of Defence (MoD) described as a "strictly defensive and independent" mission. Britain's PM Sir Keir Starmer, who together with French President Emmanuel Macron is championing the mission, has said the shipping mission would only take place once fighting in the region ends.

shaping strategy. US intelligence has assessed.

Russia's foreign ministry said it, along with Saudi, is calling for continued diplomatic efforts to reach a "sustainable, long-term pact" to end the war. Egyptian and Qatari diplomats have reiterated diplomacy is the sole path to finding a solution, as per a readout of a Saturday phone call between Egyptian Foreign Minister Badr Abdelatty and his Qatari counterpart

Sheikh Mohammed bin Abdulrahman Al Thani.

PM Shehbaz Sharif said Pakistan has been in touch with the US and Iran to extend the ceasefire and reach a peace deal. Reportedly, Iran has seized an oil tanker, accusing it of "attempting to disrupt oil exports and the interests of the Iranian nation". China confirmed a Marshall Islands-flagged tanker carrying Chinese crew members had been attacked near the strait.

## WAR SNIPPETS

### CHINESE EXPORTS JUMP 14.1 PER CENT

China's exports rose 14.1% in April from a year ago, gov't said, despite the Iran war and lingering impacts from US tariffs. The data was released days ahead of a meeting between US President Trump and Chinese leader Xi Jinping in Beijing next week. That beat estimates and was a significant improvement from March's 2.5% YoY expansion. Imports climbed 25.3%, slower than the 27.8% growth in March but still robust.

### EX-US SPY TO RUN FOR ISRAELI PARL

A former US intelligence analyst who spent 30 years in prison for spying for Israel has apologised for his actions. Jonathan Pollard also announced he would run for Israel's parliament, the Knesset, in the upcoming elections later this year. In an interview with NPR, Pollard said, "I made a mistake; I didn't think about the consequences. And 30 years later, here I am trying to leave a better legacy." Pollard was arrested in 1985 after passing highly classified US documents.

# Top Sri Lankan monk arrested for alleged sexual abuse of girl

Colombo: One of Sri Lanka's senior most Buddhist monks has been arrested for the sexual abuse of a girl, the police said on Saturday.

Venerable Pallegama Hemarathana, 71, is the chief priest of a prominent temple in the country. He was taken into custody on Friday night after a court in the holy city of Anuradhapura issued an arrest warrant against him and the victim's mother for allegedly aiding and abetting child abuse. He has been remanded until May 12.

The victim is a girl who is now 15 years old, according to the police, who was allegedly abused on the premises of a temple in Anuradhapura, police spokesperson FT



Wootler told reporters.

A complaint was registered in March. It was initially about abduction and detention of a minor, reported the Daily Mirror media portal. When a probe was initiated, the investigators found out more.

Hemarathana was arrested from the emergency unit of a private hospital in Colombo, around 200 km from Anuradhapura, where he was undergoing some treatment, police said. The mother has also been arrested.

# Patient zero in ship hantavirus outbreak identified as a Dutch national

A Dutch birdwatcher who visited a landfill site described as the "end of the world" has been identified as patient zero in the deadly hantavirus outbreak on board the MV Hondius cruise ship.

Ornithologist Leo Schilperoord, 70, boarded the MV Hondius with wife after making a fateful visit to the rubbish tip in Argentina. Leo was the first passenger to lose his life to the virus while on board the vessel. His wife, Mirjam Schilperoord, disembarked the ship with his body but tragically died while attempting to board a flight to the Netherlands from South Africa.

The couple, from Haulerwijk, a small village of 3,000 people in the Netherlands, were named in

obituaries published in their local monthly village magazine, the Sun reports.

Prior to boarding the MV Hondius, Leo and Mirjam had been on a five-month trip across South America. On March 27, they visited a landfill site four miles outside the city of Ushuaia. The vast rubbish tip on the town's outskirts is home to rare species of Patagonian birds, including the White-bellied Seedsnipe. The site, dubbed "the end of the world" and shunned by locals, is a popular destination for birdwatching tourists.

Argentinian authorities believe the Dutch couple contracted the feared Andes strain of the hantavirus at the site, likely through exposure to infected rodents at the rubbish dump. Four days later, on



April 1, the couple set sail on the MV Hondius from Ushuaia, alongside 112 other passengers. By April 6, Leo reported suffering from a fever, headache, stomach pain and diarrhoea. He passed away on the ship five days later, with his body remaining on board until April 24 when the ship docked in St Helena.

Mirjam travelled with his body to South Africa but she also became unwell. Her health worsened as she got ready to catch a KLM flight from Johannesburg to Amsterdam. She briefly got on board but

was denied clearance to travel and was instead rushed to hospital in South Africa where she passed away a day later on April 26. A third person from the ship, a German passenger, has also died. The tally has reached six, WHO said. Of these, three British citizens have confirmed cases.

# Indian-American man faces denaturalisation proceedings in US

New York: A 62-year-old man from India, who later became a US citizen, is facing denaturalisation proceedings after it emerged he conspired to defraud investors of \$2.5 million and did not disclose this information to the federal authorities here.

Debashis Ghosh is a naturalised US citizen whose last known residence is in Cook County, Illinois. He entered the US multiple times on various non-immigrant visas beginning as early as 1991 and became a US citizen in 2012.

Ghosh is among 12 individuals against whom the US Dept of Justice announced it has filed denaturalisation actions in US district courts.

The 12 individuals are accused of serious offences, including providing material support to a terrorist group, committing war crimes and sexually abusing a minor.

The US Justice Dept said before Ghosh naturalised, he conspired to defraud investors of \$2.5 million intended for the construction of an aircraft maintenance facility.

After naturalising, Ghosh continued the fraudulent scheme, misrepresenting the location and safekeeping the investor funding. In his 2012 naturalisation application and interview, Ghosh claimed he had never committed a crime for which he had been arrested. —PTI

# US proposes higher wage for H1B hires

The US has proposed to increase the minimum wages paid to hire an employee under the H1B visa programme by 30% over the previously fixed limits, a move the administration claims will help prevent foreigners from undercutting wages of US nationals. The new rule, proposed by the US Dept of Labour on March 27, seeks to raise the minimum wages for four categories from entry-level to the most-experienced, contending the existing wage levels were fixed 20 years ago and fail to adequately protect US workers. According to the proposed rule 'Improving Wage Protections for the Temporary and Permanent Employment of Certain Foreign Nationals in the United States', the prevailing wage for entry-level foreign workers was USD 73,279 per annum, USD 98,987 (Level II), USD 121,979 (Level III) and USD 144,202 (Level IV). The new rule, which is now open to public comments till May 26, seeks to increase the prevailing wages for entry-level workers to USD 97,746, a hike of 33.39 per cent over the old rates, USD 123,212 (Level II, 24.47 per cent), USD 147,333 (Level III, 20.79 per cent), and USD 175,464 (Level IV, 21.68 per cent). The prevailing wages differ from city to city. According to the Department of Labour, the current methodology allows employers to hire foreigners at wage levels significantly below those paid to similarly employed US. The proposed changes will dramatically increase the prevailing wage levels used in the H1B, H1B1, E-3, and PERM labour certification programs. —PTI

# Starmer brings in Gordon, Harriet to ease pressure

London: Sir Keir Starmer has brought in Gordon Brown and Harriet Harman as advisers to ease pressure on the PM to resign after the disastrous election results for Labour.

Brown, the former premier and long-serving chancellor under Tony Blair, has been made Starmer's envoy on global finance, with a brief to advise on financial partnerships to help with defence-related investments, particularly with Europe. Harman, who was Labour's deputy leader under Brown, will be the prime minister's adviser on women and girls, focusing on tackling violence and improving economic opportunities, The Guardian reports.

While the roles are part-time and unpaid, there is deliberate symbolism in Starmer gathering Labour heavyweights around him as he battles to save his job, particularly with the optics of Brown being pictured with him at Downing Street on Saturday morning.

With the bulk of the votes now counted from Thursday's series of elections, Labour lost over 1,400 councillors in England, shedding support to Reform UK and the Greens in traditional heartlands. In Wales, the party lost power for the first time, plummeting to just nine Senedd seats behind Plaid Cymru and Reform UK.

while losing ground in the Scottish parliament.

While none of Starmer's cabinet have yet moved, other Labour MPs have called on him to set a date to hand over the leadership, including Clive Betts, the long-serving Sheffield South East MP, and Debbie Abrahams, for Oldham East and Saddleworth.

Abrahams told the BBC on Saturday morning she hoped Starmer would "always put the country first" given the electoral threat from Reform. "We have to recognise the dangers that we're in now, that on this trajectory it doesn't look good." Asked how quickly he should consider departing, Abrahams said: "I think it is a matter of months."

# PÉTER MAGYAR IS SWORN IN AS HUNGARY'S NEW PREMIER

Budapest: Péter Magyar called for those who occupy high office, described as remnants of the Orbán regime, to vacate their posts by May 31. The order was extended to specifically include the country's President Tamás Sulyok. Péter Magyar has been sworn-in as Hungary's new PM, after taking his oath in parliament on Saturday morning, bringing an end to 16-years of Viktor Orbán rule, cementing a landslide April election victory.

Magyar post was confirmed on Saturday in the inaugural session of the National Assembly. He was appointed with 140 votes in favour, 54 against and 1 abstention.

After taking the oath, Péter Magyar said people had given



his Tisza party a mandate to lead a new chapter in the country's history, to change not only the government but the system as well. "I will not rule over Hungary, I will serve my homeland," he stressed. "However, there can be no new beginning without reconciliation, and no reconciliation without justice," he added. "In the house of Hung-

arian democracy, I call on those holders of high public office who were the servants of the previous system to resign today, or by 31 May at the latest," said the new PM, adding, "President Tamás Sulyok should be the first to do so."

Breaking 36-years of tradition and protocols pertaining to government change, former PM Viktor Orbán did not deliver a speech at the inaugural parliamentary session, nor was he even present for the proceedings.

Ágnes Forsthofer, Vice President of the Tisza Party, was elected the new speaker of parliament, and she was quick to announce her first order of business, reinstalling the EU flag on the Hungarian parliament building, after around 12 years of absence.


