**Approval for re-classification of certain 'promoters/ promoter group' category to 'public' category**

The Board was apprised that the Company has received request letters from the following entities for re-classification from the 'promoter/ promoter group' category to the 'public' category in terms of Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('SEBI Listing Regulations'):

Copies of the said request letters were placed at the meeting and taken on record.

The provisions of Regulation 31A of the SEBI Listing Regulations prescribing the process to be followed for reclassification of 'promoters/ promoter group' into 'public' category and the conditions to be fulfilled by the Outgoing P&PG was briefed to the Board.

**The Board analyzed the request received and noted the following:**

- a) Outgoing P&PG are not directly or indirectly associated with the business of the Company and do not have any influence over the business and policy decisions made by the Company anymore.
- b) Outgoing P&PG are neither involved in the day-to-day activities of the Company, nor do they exercise any control over the affairs of the Company.
- c) Outgoing P&PG do not have any of their representative on the Board of Directors of the Company or as key managerial personnel of the Company.
- d) There are no regulatory actions pending against the Outgoing P&PG.
- e) Outgoing P&PG have confirmed that they satisfy all the conditions specified in sub-clause (i) to (vii) of clause (b) of sub-regulation (3) of Regulation 31A of SEBI Listing Regulations and have also confirmed that they shall continue to comply with the conditions mentioned in Regulation 31A of SEBI Listing Regulations post re-classification from 'promoter/ promoter group' to 'public' category, as applicable

The Board further noted that pursuant to Regulation 31A of the SEBI Listing Regulations, the proposed re-classification is subject to the approval of the Board of Directors, the Stock Exchanges and/or any other approval, as may be required. The Board also noted that the said Regulations provide that where the outgoing promoters (along with the persons related to such promoter) do not hold more than 1% of the equity share capital or voting rights in the Company, approval of the shareholders is not required for such re-classification.

Accordingly, in the present case, since the Outgoing P&PG together do not hold any equity shares or voting rights in the Company, the re-classification request does not require the approval of the shareholders of the Company.

On the basis of the rationale provided above and in accordance with the provisions of Regulation 31A of the SEBI Listing Regulations, the Board considered and approved the request of Outgoing P&PG for its re-classification from the 'promoter/ promoter group' category to 'public' category.

The Board noted that none of the Directors of the Company are interested in this resolution.

*The Board discussed the matter and after analysis and deliberation approved the proposal and passed the following resolution unanimously:*
